
Does your university's written strategy promote the use of e-exams?


How many e-exams* are carried out at your university per year?

Which of the following tools* do you use for e-exams at your university?




Is there a centralized e-assessment service provider at your university?

Are e-exams at your university carried out in a secure environment (for example lockdown browser) to prevent fraud?





How many SEB-exams have you carried out since January 2016 at your university?



Do you use SEB in a setup with a Virtual Desktop Infrastructure (VDI)?






SEB integration in additional LMSs and E-Assessment Suites (for example Canvas)




Optional support for multimedia functionaliy like webcam and microphone input

Optional support for acessibility tools like screen readers, magnifier





Centralized database for prohibited third party tools and applications, which should not run during an exam using SEB.

- The database file can be imported into a SEB configruation file (or later directly downloaded by SEB)
- SEB checks if a prohibited application from this "blacklist" is running and instructs the user to quit it first before starting an exam
- This will prevent to use tools like screen recording or screen sharing during exams

SEB JavaScript API for server functionality

- Process monitoring, so exam system can react if unwanted applications are running/get started on exam clients
- Detect when a client loses connection (was restarted or SEB was terminated)
- Check for code signatures to make sure correct (not renamed or otherwise manipulated) third party software is used






Tablet versions (Windows tablet, iPad)

- Improved support for freehand drawings, with focus on natural pen/pencil drawing usability
- Use tablet as second screen for allowed documents during exam, for example lecture script
- Using tablet computers with digital pens/styluses as an additional input device connected with a desktop exam computer for drawing/sketching/ annotations in exams, while using the desktop clients for text essay questions and virtual desktop third party exam tasks



Improved methods for checking integrity (code signature) of the SEB version used, especially important for BYOD scenarios


- Improve current check for configuration and application integrity inside SEB
- New standalone tool which can be run before an exam by proctors to verify the correct SEB version is used on a student device

Other comments on e-exams

«Eine Gruppe von Spezialisten (IT Fachdozierende) in der Hochschule haben mehrmals Prüfungen mit BYOD und dem Lernstick (mit Browser und Withlist's) getestet. Dieses Szenario funktioniert noch nicht so gut, dass es standardisierbar ist»

«We are in discussions on eassessments but are waiting to have management support for the project. There are many lecturers who would like to go ahead with this so I am confident that we will also be on board with eassessment in the future»

«We will use more and more online-exams at our university, we are very interested in VDI because at the moment we are conducting also online-exams without SEB»

«We are currently thinking about e-assessments in the field of Massive Open Online Courses»

Other comments on SEB

«We intent to evaluate the use of SEB for BYOD exams. Before 2013 we already used SEB but never on student's devices»

«There are needs for a lockdown setup like SEB, but the number of candidates usually exceeds the number of machines in the largest room by a factor of 2-3, so we are reluctant to introduce it at the moment»

«Wir haben früher den SEB auf gemanagten Geräten eingesetzt. Durch den strategischen Entscheid der Leitung nur noch Open-Internet Prüfungen zu erlauben, haben wir ihn wieder aus dem «Angebot» genommen. Aus technischer Sicht ist der Aufwand für die Nutzung und den Support von SEB zu gross. Wir haben für Betrieb und Entwicklung keine Ressourcen»
